DEED POLL REGULATIONS

- 1. Each Member Association shall take all necessary steps to require and ensure that each of that Member Association's current:
 - (a) members;
 - (b) registered boxers; and
 - (c) registered boxing officials;

forthwith execute a Deed Poll in the form set out in the Appendix to these Regulations (save for the substitution of the Member Association's name in place of "[Member Association]" where the latter appears in the Appendix); and, further, forward the Deed Poll so executed to the Secretary of the Member Association.

- 2. Upon receipt of each Deed Poll executed in accordance with regulation 1 of these Regulations, the Secretary of the Member Association concerned shall forthwith forward the same to the Chief Executive Officer of Boxing Australia Limited.
- 3. Each Member Association shall require each applicant for membership of that Membership Association :
 - (a) to execute a Deed Poll in the form set out in the Appendix to these Regulations (save for the substitution of the Member Association's name in place of "[Member Association]" where the latter appears in the Appendix) prior to the Committee of the Member Association dealing with the application in accordance with clause 8.3 of the Constitution of the Member Association; and
 - (b) further, to forward the Deed Poll so executed to the Secretary of the Member Association.
- 4. In the event that the Committee of the Member Association approves an application for membership of the Member Association, the Secretary of the Member Association concerned shall forthwith forward to the Chief Executive Officer of Boxing Australia Limited the Deed Poll executed by the successful applicant in accordance with regulation 3 of these Regulations.
- 5. Each Member Association shall require each applicant for registration as a boxer with that Member Association :
 - (a) to execute a Deed Poll in the form set out in the Appendix to these Regulations (save for the substitution of the Member Association's name in place of "[Member Association]" where the latter appears in the Appendix) prior to the Committee of the

- Member Association dealing with the application in accordance with clause 18.2 of the Constitution of the Member Association; and
- (b) further, to forward the Deed Poll so executed to the Secretary of the Member Association.
- 6. In the event that the Committee of the Member Association approves an application for registration as a boxer with the Member Association, the Secretary of the Member Association concerned shall forthwith forward to the Chief Executive Officer of Boxing Australia Limited the Deed Poll executed by the successful applicant in accordance with regulation 5 of these Regulations.
- 7. Each Member Association shall require each applicant for registration as a boxing official with that Member Association :
 - (a) to execute a Deed Poll in the form set out in the Appendix to these Regulations (save for the substitution of the Member Association's name in place of "[Member Association]" where the latter appears in the Appendix) prior to the Committee of the Member Association dealing with the application in accordance with clause 19.2 of the Constitution of the Member Association; and
 - (b) further, to forward the Deed Poll so executed to the Secretary of the Member Association.
- 8. In the event that the Committee of the Member Association approves an application for registration as a boxing official with the Member Association, the Secretary of the Member Association concerned shall forthwith forward to the Chief Executive Officer of Boxing Australia Limited the Deed Poll executed by the successful applicant in accordance with regulation 7 of these Regulations.
